

Compliance

Surf clubs, although considered a volunteer service, still have a responsibility under the <u>WHS Act 2012 (SA)</u> and <u>WHS Regulation 2012(SA)</u>. Access to more information is available to <u>Safework SA</u> – Resources We are obliged to report Notifiable Incidents which are defined as:

- Death of a person.
- Serious injury or illness.
 - Dangerous incident.
- A serious Injury or Illness as a result of an incident includes:
 - Admission as an in-patient in a hospital.
 - Immediate treatments, such as:
 - Amputation.
 - Serious head, eye, or spinal injuries.
 - Serious burns or skin separation (e.g. degloving).
 - Loss of bodily function or serious lacerations.
 - Medical attention within 48 hours following exposure to a harmful substance.

A person who conducts a business or undertaking must ensure that the regulator is notified immediately after becoming aware that a notifiable incident arising out of the conduct of the business or undertaking has occurred. The Patrol Captain must notify the Club Captain and President immediately if a notifiable incident has occurred during patrol or at any time a member is carrying out duties for the club.

On The Beach

It is important that all preventative actions are taken to minimise the risk of rescues and injuries.

Definitions of Rescues:

A rescue is defined as "Retrieving a person in distress, delivering them to safety and the application of first aid and basic life support as may be required."

Understanding Preventative Actions:

Preventative action is defined as "Direct action taken to reduce or eliminate the probability of a specific rescue, first aid or other reportable incident from happening in the future. Note: A preventative action will be recorded as the singular activity taken (i.e. clearing the water for lightning will be one action)"

Importance of Risk Assessment:

Performing risk assessments at the beginning and throughout the patrol is important to ensure the safety of beachgoers. This includes evaluating water conditions, weather and identifying potential hazards. If any hazards are identified, it is crucial to take preventative actions to eliminate and reduce the associated risks.

Logging Preventative Actions

It is always crucial to remember to log preventative actions - this information is used to continuously remind the government of the work volunteers do and helps maintain or increase the funding to Surf Life Saving.
